#### Invitation to Tender

#### 1. Introduction

Due to the limitations of the current AFTN/AMHS connections, ICAO has proposed the improvement of network connectivity using the Common aeRonautical Virtual Private Network (CRV) of Asia/Pacific Region. The CRV is an MPLS network based on terrestrial, and satellite. CRV will be implemented by all ANSPs of states within the Asia Pacific region as the solution for replacing the current connections.

Aeronautical Radio of Thailand Ltd., hereinafter called AEROTHAI, a state enterprise under Ministry of Transport, is delegated by the Royal Thai Government to be Air Navigation Service Provider(ANSP) of Thailand to provide air navigation services as well as aeronautical information services for airline operations within Bangkok Flight Information Region (FIR), is seeking proposal from the supplier for the service provider of Common aeRonautical Virtual Private Network (CRV) for the data connection between Thailand and Hong Kong.

The components of Tender Documents are Price Proposal and Technical Proposal together with general documents such as certified copies of incorporation documents, affidavit or by-laws, Power of Attorney (Submission) and a copy of Tax registration and/or Value Added Tax registration (if any). These components specify the requirements, terms and conditions of the AEROTHAI's requirements to be strictly complied with by Tenderers in Preparation of Tenders and shall not be modified by Tenderers.

The Tenderer shall submit his Tender on the understanding that the Tender Documents (and the Tenderer's response thereto) are intended to cover all the Activities within the scope of the Contract and that, unless expressly excluded in his Tender, any and all labor and materials not indicated therein, but which may be necessary to complete any part of the Activities in a proper and workmanlike manner, are to be considered as included and are to be furnished by the Tenderer at his costs.

## 2. General Tenderer Qualifications

The following qualifications must be met:

- 2.1 The Tenderer shall be a juristic person professionally in business of the leasing of Common aeRonautical Virtual Private Network (CRV)
  - 2.2 No joint venture or consortium or the likes will be eligible for tender submission.
- 2.3 The Tenderer shall not be on the blacklist of AEROTHAI or of other state enterprises or of any Thai government agencies as formally announced.
- 2.4 The Tenderer shall not be a "jointly interested Tenderer", have any co-interest with any other Tenderer, and/or obstruct fair price competition during Tender Period in accordance with the "Regulations of the Ministry of Finance Governing Government Procurement and Supplies Management B.E. 2560".
- 2.5 The Tenderer shall submit a Letter of No Special Privilege of Immunity as form prescribed by AEROTHAI, with this proposal a confirmation letter that the firm is without a special privilege or immunity with which to refuse being taken to Thai Court, or if he has such privilege or immunity, that such privilege or immunity shall be waived for the purpose of participating in the said proposal.
- 2.6 No AEROTHAI officer is connected with the Tenderer as a manager, managing partner, managing director, executive or person authorized to operate business of a natural person or juristic person, or a partner in ordinary partnerships or limited partnership, or a major shareholder in limited companies or public limited companies, or a consultant to such business.

## 3. Scope of Services

# 3.1 Scope of Work

The Tenderer shall provide the MPLS-based IPVPN Solution for AEROTHAI data communications with Hong Kong, with prospective data communication between Thailand and China (Beijing), Singapore, India and Myanmar in the near future. With the following characteristics:

- (a) Full Mesh MPLS VPN service with dual terrestrial links as local access
- (b) Managed Router service with dual Customer Premises Equipment (CPE)
- 3.1.1 Technical Specification
  - (a) The Tenderer shall provide Package Subscription (SLA) 2 different paths from 2 different POPs and using 2 different local loop providers.
  - (b) The Tenderer shall install on the 2nd floor of the 60th Anniversary Building of AEROTHAI's Headquarters.
  - (c) The Tenderer shall provide service with the following technical parameters (Bandwidth + network spec)
    - i. Network Type: MPLS VPN services with dual terrestrial links

  - (d) The Tenderer shall provide Project Milestone Activities & Task Summary (Expected Period of Time) including

    - iv. Target Ready for Service

  - (d) Jitter Level
  - (e) Mean Time to Restore
- 3.2.11 The Tenderer shall provide monthly report for AEROTHAI on network performance such as
  - (a) Service Availability
  - (b) Round Trip Delay
  - (c) Packet Drop Ratio
  - (d) Jitter Level
  - (e) Mean Time to Restore
- 3.2.12 The Tenderer shall provide an alert/alarm mechanism such as e-mail or SMS to inform AEROTHAI in case of any link connection failure
- 3.3 Service Availability Level and Payment Deduction for downtime
  - 3.3.1 The tenderer will use its reasonable efforts to provide the MPLS VPN Service, Managed Router Service and Satellite VSAT service acted as Local Access at the Service Availability of 99.97%

## 3.3.2 Payment Deduction:

In the event that the tenderer fails to meet the Service Availability Level in a calendar month, AEROTHAI shall be entitled to claim a credit equal to the percentage of the monthly recurrent charge of the affected AEROTHAI site for that calendar month as performance remedy in accordance with the below table.

Downtime is calculated from the start to the end of any disruption.

In case a fault is experienced between an end user of a terrestrial MPLS and an end user of a satellite MPLS, then the fault report shall be used to establish where and why the disruption occurred, and payment deduction imposed using the service level of Satellite MPLS.

# 3.4 Round Trip Delay Guarantee

- 3.4.1 On and from the Service Commencement Date, The Tenderer shall use reasonable efforts to ensure that the Average Round Trip Delay for those specified routes set out in Appendix 2 that the MPLS VPN Main Services are riding on does not exceed the Target Average Round Trip Delay (which is stated in Appendix 2) in any calendar month ("Round Trip Delay Guarantee").
- 3.4.2 The measurement point is between CPE-to-CPE installed in the AEROTHAI site and the value in any calendar month is according to that measured by The Tenderer and posted in the Online Service Portal.
- 3.4.3 In the event that The Tenderer fails to meet the Round Trip Delay Guarantee in a given calendar month, the affected AEROTHAI shall be entitled to 1% of one month's recurrent charge of AEROTHAI site for that calendar month.

# 3.5 Packet Drop Ratio Guarantee

- 3.5.1 On and from the Service Commencement Date, The Tenderer shall use reasonable efforts to ensure that the Average Packet Drop Ratio for traffic travelling between two locations set forth in Service Coverage List (Appendix 1) related to MPLS VPN Main Service in a calendar month does not exceed the Target Average Packet Drop Ratio ("Packet Drop Ratio Guarantee"). The Target Average Package Drop Ratio for data application is 0.5%.
- 3.5.2 The measurement point is between CPE-to-CPE installed in AEROTHAI site and the value in any calendar month is according to that measured by The Tenderer and posted in the Online Service Portal. If the local access connected to MPLS VPN main port and/or MPLS VPN backup port is via Satellite VSAT service, the Packet Drop Ratio Guarantee is not applicable.
- 3.5.3 In the event that The Tenderer fails to meet the Packet Drop Ratio Guarantee in a given calendar month, the affected AEROTHAI shall be entitled to 1% of one month's recurrent charge of AEROTHAI site for that calendar month.

### 3.6 Jitter Level Guarantee

- 3.6.1 On and from the Service Commencement Date, The Tenderer shall use reasonable efforts to ensure that the Average Jitter Level for the traffic travelling between two locations set forth in Service Coverage List (Appendix 1) related to MPLS VPN Main Service in a calendar month does not exceed the Target Average Jitter Level ("Jitter Level Guarantee"). The Target Average Jitter Level for data application is 250ms.
- 3.6.3 The measurement point is between CPE-to-CPE installed in Authority site and the value in any calendar month is according to that measured by The Tenderer and posted in the Online Service Portal. If the local access connected to MPLS VPN main port and/or MPLS VPN backup port is via Satellite VSAT service, the Jitter Level Guarantee is not applicable.
- 3.6.4 In the event that The Tenderer fails to meet the Jitter Level Guarantee in a given calendar month, the affected AEROTHAI shall be entitled to 1% of one month's recurrent charge of AEROTHAI site for that calendar month.

### 3.7 Mean Time to Restore Guarantee

3.7.1 In the event of Outages, The Tenderer will use its reasonable efforts to ensure the Mean-Time-To-Restore (MTTR) for such Services located in locations set forth in Service Coverage List (Appendix 1) will not exceed the Target Mean-Time-To-Restore of 4 hours

Outages in this clause 3.7.1 refer to:

- (a) failure of terrestrial local access for the affected AEROTHAI site (Satellite VSAT link is not included); or failure of MPLS VPN port for the affected AEROTHAI site; or
- (b) failure of CPE for the affected AEROTHAI site
- 3.7.2 The CPE maintenance service level is under Premium Four Hour Response Level (7x24x4).
- 3.7.3 During service restoration, the idle time related to getting permit from AEROTHAI for The Tenderer, its suppliers and subcontractors access to AEROTHAI site will be excluded from the time to restore.
- 3.7.4 In the event that The Tenderer fails to meet the MTTR Guarantee in a given calendar month, the affected AEROTHAI shall be entitled to 1% of one month's recurrent charge of the AEROTHAI site for that calendar month.
- 3.7.5 For the avoidance of doubt, the affected AEROTHAI refers to the outages happened in the particular AEROTHAI site.

- 4.1.3 AEROTHAI will acknowledge via e-mail a receipt of the Tender submitted in due time and the date and time of such receipt shall be regarded as the official time of receipt.
- 4.1.4 Tender received by AEROTHAI in due time shall not be changed, altered, modified or withdrawn, whether in whole or in part, but certain clarifications not changing or violating the substance or any AEROTHAI's requirements for the best interest of AEROTHAI may be accepted.

### 4.2 Tender Costs

All and any costs incurred in the preparation and submission of the Tender and all matters arising therefrom shall totally be at the Tenderer's expense. AEROTHAI will in no case be responsible or liable for those costs.

# 4.3 Preparation of Tender

Tender must be direct, concise, and complete. AEROTHAI will evaluate Tenderer's Proposal based on its clarity and the directness of its response to the AEROTHAI's requirements as outlined in this Invitation to Tender.

- 4.3.1 Language: All of the Tenders shall be completed in English and references in any other language shall be accompanied by an English translation thereof, certified by an appropriate translation authority (the Ministry of Foreign Affairs, Embassy, or the likes).
- 4.3.2 Authentication: All pages of the original Tender shall be affixed with the Tenderer's company seal (if any) and manually signed by an authorized person to bind the Tenderer and a Power of Attorney indicating such authority shall be submitted.
- 4.3.3 Organization: The tender shall be organized at least in the following three (3) parts:

### 4.3.3.1 Qualification Documents, consisting of:

4.4.2 SECTION 2: Technical Approach

This Section shall provide a work process and plan to describe how the Tenderer intends to accomplish each specific task in Clause 3.1, which should also identify important milestones consistent with each specific delivery schedule in Clause 3.2.

4.5 Price Proposal

Price Proposal, sealed in a separate envelope and labeled as "Price Proposal", shall contain the cost of one time installation, monthly recurring service and payment deductions offer. All the prices will be in US Dollar. Price Proposal shall remain valid for a period of one hundred and twenty (120) calendar days from the Tender Submission Date.

4.6 Tender Evaluation and Opening Price Proposal

After General Tenderer Qualification Examination and Technical Evaluation which comply with AEROTHAI's requirements, the Committee in Charge of Lease by the Specific Method will inform the Tenderer the date which the Price Proposal will be opened.

4.7 Reserved Rights

- 4.7.1 AEROTHAI reserves the right to invite or request the Tenderer to clarify any issues as it deems necessary, provided that Tenderer shall provide such clarification(s) without changing or violating in any way the substance of their Proposal.
- 4.7.2 AEROTHAI reserves the right to accept or reject Tender in whole or in part which it considers to be in its best interests.
- 4.7.3 AEROTHAI reserves the right to cancel the Request/Invitation to Tender or reject the Tenderer, based on its best interest.
- 4.7.4 AEROTHAI will be the sole judge as to whether any Tender complies with the Tender Documents. Any such decision by AEROTHAI shall be final and conclusive.
- 4.7.5 AEROTHAI shall not be responsible for any or all costs and expenses arising from the preparation, presentation, negotiation, meeting or any expense relating to the Tender Submission of the Tenderer.
- 4.7.6 AEROTHAI reserves the right to modify any of the conditions contained in the Purchase Order before placing to the comments (if any) of the Office of the Attorney General.
- 4.7.7 AEROTHAI reserves the right to reject the Tender if the Tenderer has not received Tender Documents directly from AEROTHAI.


